Dear Sirs,

This is further to our letter of 16th January 2017, intimating that the Board of Directors of the Company had accorded an in principle approval for divesting its stake in its Joint Venture, Zhejiang Tata Tea Extraction Company Limited (ZTTEC), subject to necessary approvals. In the said letter we had mentioned that the transaction was subject to completion of negotiations, definitive agreements and satisfaction of conditions precedent. We now inform you that the divestment of the Company's stake has been completed. The details are as under:

- a) The amount and percentage of the turnover or revenue or income and net worth contributed by such unit or division of the listed entity during the last financial year: The turnover contributed by ZTTEC for the year ended 31st March, 2017 was Rs. 2.51 crores and the contribution of ZTTEC towards Net worth as of 31st March 2017 was Rs.13.98 crores.
- b) date on which the agreement for sale has been entered into: 6th April 2017 (subject to satisfaction of conditions precedent).
- c) The expected date of completion of sale/disposal: 28th July 2017.
- d) Consideration received from such sale/disposal: RMB 18.49 Million.
- e) brief details of buyers and whether any of the buyers belong to the promoter/ promoter group/group companies. If yes, details thereof: Zhejiang Tea Group Co. Limited, China are the buyers and they do not belong to the promoter/ promoter group/group companies
