Sub: Capacity Expansion - Tata Coffee Vietnam Company Limited, Vietnam

Dear Sir, Madam,

In accordance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosures Requirements) Regulations, 2015 (“**Listing Regulations**”), we would like to notify that, the Scheme Implementation Committee of the Board of Directors of the Company at its meeting held on November 30, 2023, has approved the setting up of an additional 5500 MT Freeze-Dried Coffee facility in Vietnam. This facility is being undertaken by Tata Coffee Vietnam Company Limited, a step-down wholly-owned subsidiary of Tata Coffee Limited. Tata Coffee Limited is a subsidiary of the Company.

We wish to further inform that the Company has entered into a Composite Scheme of Arrangement with Tata Coffee Limited and TCPL Beverages & Foods Limited (wholly-owned subsidiary of the Company) and their respective shareholders and creditors, pursuant to the provisions of Sections 230 to 232 of the Companies Act, 2013, and the said Scheme has recently been approved by Hon’ble National Company Law Tribunals, Bengaluru and Kolkata. This Scheme will be effective once the conditions mentioned in Clause 29 of the Scheme are all satisfied. Upon the Scheme becoming effective, Tata Coffee Limited shall stand amalgamated with the Company, resulting in a change in ownership for Tata Coffee Vietnam Company Limited from Tata Coffee Limited to the Company, subject to the necessary approvals, as may be required, for this purpose. Consequently, Tata Coffee Vietnam Company Limited will become a wholly-owned subsidiary of the Company.

In view of this, basis the approval granted to the above proposal for the expansion of capacity in Tata Coffee Vietnam Company Limited by the Board of Directors of Tata Coffee Limited and by the Members’ Council of Tata Coffee Vietnam Company Limited, the Scheme Implementation Committee of the Board has approved such capacity expansion, considering that the effective date of the Scheme is expected in the near future.
