Sub: Re-appointment of Independent Directors for a second term of 5 years

Dear Sir/Madam,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 ('Listing Regulations'), we wish to inform you that the Board of Directors of the Company, at their meeting held today, Thursday, March 14, 2024, based on the recommendation of the Nomination and Remuneration Committee, and subject to the approval of the shareholders of the Company, have unanimously approved:

- 1. Re-appointment of Mr. Bharat Puri (DIN: 02173566) as an Independent Director for a second term of five years, i.e., from May 7, 2024, to May 6, 2029.
- 2. Re-appointment of Ms. Shikha Sharma (DIN: 00043265) as an Independent Director for a second term of five years, i.e., from May 7, 2024, to May 6, 2029.

Mr. Bharat Puri and Ms. Shikha Sharma have confirmed that they meet the criteria of 'independence' under Section 149 of the Companies Act, 2013, and Regulation 16 of the Listing Regulations. Further, they have also confirmed that they have not been debarred from holding the office of Director by virtue of any Order passed by the Securities and Exchange Board of India or any other such authority.
